COUNT 1

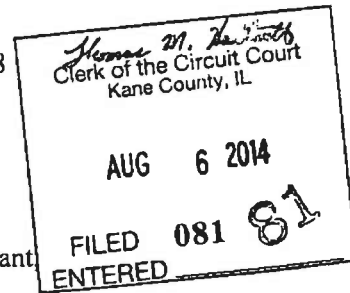
The Grand Jury charges that on or about November 11, 2012, defendant

MARK LEWIS

committed the offense of AGGRAVATED CRIMINAL SEXUAL ASSAULT,
Class X Felony,

in violation of Chapter 720 , Section 5/11-1.30(a)(2) of the Illinois Compiled Statutes, of said State, in that the said defendant, while committing a Criminal Sexual Assault in violation fo Chapter 720 ILCS 5/11-1.20(a)(2) of the Illinois Compiled Statutes committed an act of sexual penetration with J.K. in that he placed his penis in the anus of J.K., knowing J.K. was unable to give knowing consent, and while doing so caused bodily harm to J.K.

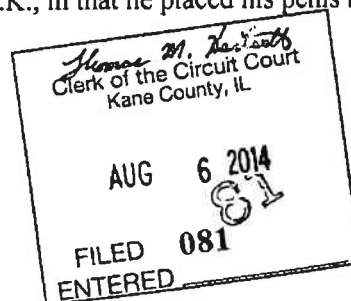
The Grand Jury charges that on or about November 11, 2012, defendant,

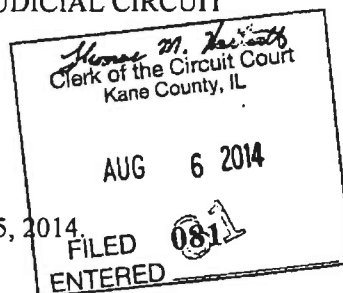
